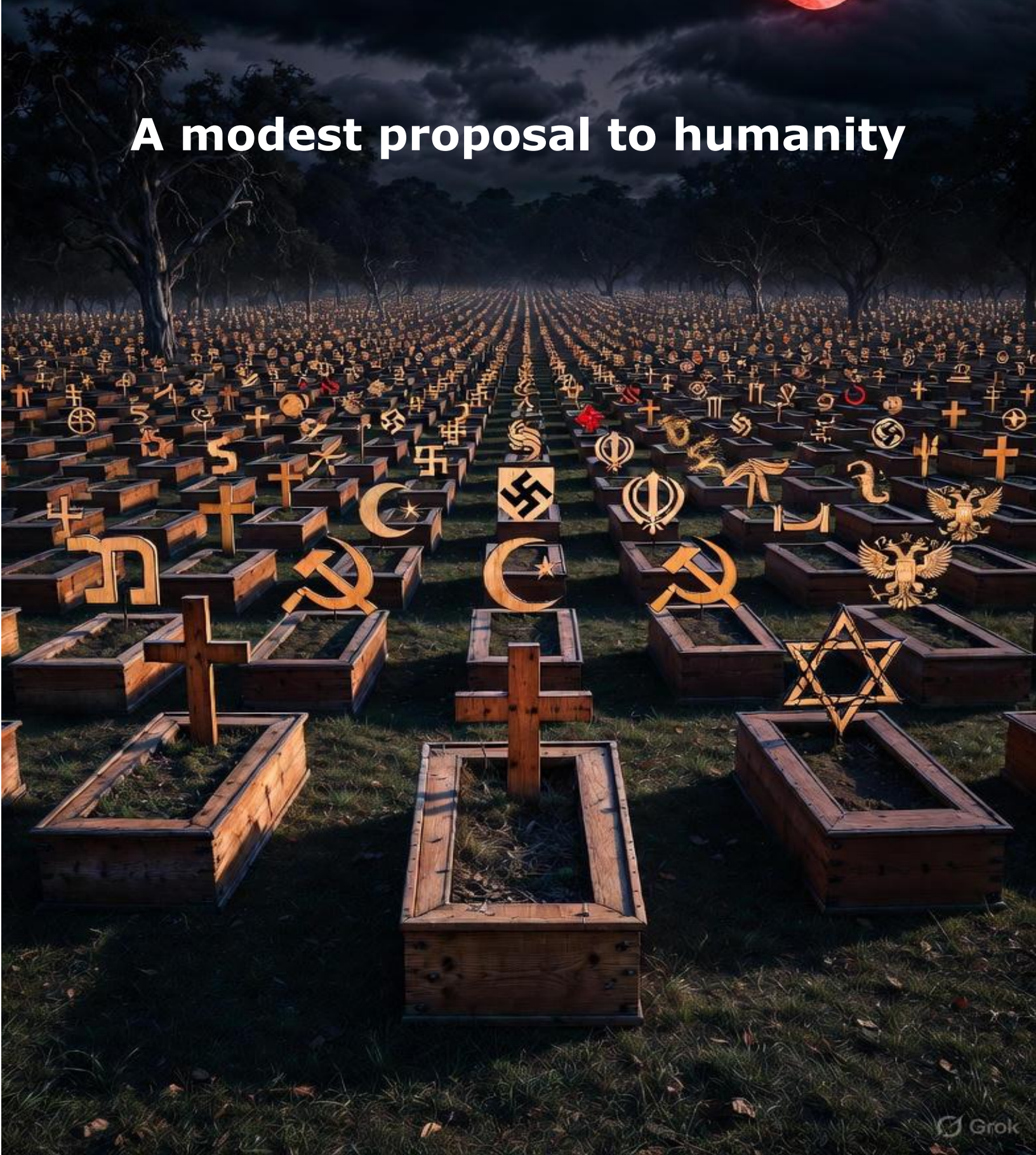

## **Part I – The universal pattern**

# Chapter 1 - Preamble

Imagine you are 12 years old and you turn on the television.

You see people killing each other in Ukraine, Gaza, Myanmar, Sudan.

You see politicians in suits saying:

"This land is ours by God. Those people are inferior by birth. We are chosen by history to rule. They must go or die."

Then you switch channel and see the same thing, but different flags and different gods.

You ask your dad: "Why do they all say the same thing?"

Dad says: "Because every group thinks they are the special one."

That is the universal pattern this book is about.

For five thousand years the same sentence has killed more children than any disease, war, or famine.

The sentence is:

"This group (us) is special by God / blood / history.

The other group (them) is less than human.

Therefore whatever we do to them is not wrong – it is destiny / purification / necessity."

We heard it from:

- Jewish rabbis quoting Deuteronomy 7:6 about the land promised forever.
- Christian priests quoting Romans 5:18 about the only saviour.
- Muslim imams quoting Qur'an 33:40 about the final prophet.
- Hindu priests quoting Manusmriti 8.414 about eternal castes.
- Buddhist monks quoting Mahavamsa about pure nations.
- Sikh gurus twisted to justify swords for Khalistan.
- Jain monks saying women need a male body for liberation.
- Nazis quoting Mein Kampf about the master race.
- Marxists quoting the Manifesto about historical necessity of liquidation.
- American presidents quoting John Winthrop about the shining city on a hill.
- Russian patriarchs quoting Philotheus about the Third Rome.
- Ukrainian nationalists quoting Dontsov about pure Ukraine.
- Chinese leaders quoting the Mandate of Heaven about the civilisation-state.
- Zionist ministers quoting Leviticus 25:44 about slaves from the nations around.



Every time the sentence was said, it ended with graves.  
Every time the graves were filled with children.

This book asks one polite question:

**What if we paused the sentence for 100 years and saw what happened?**

## **Chapter 2 – The seed and the soil**

For thousands of years, every mum in the world was told she was just a flowerpot.

The dad plants the seed.

The mum holds the pot.

"If God knew about the egg cell from the beginning, why did He let everyone treat mums like pots for thousands of years?"

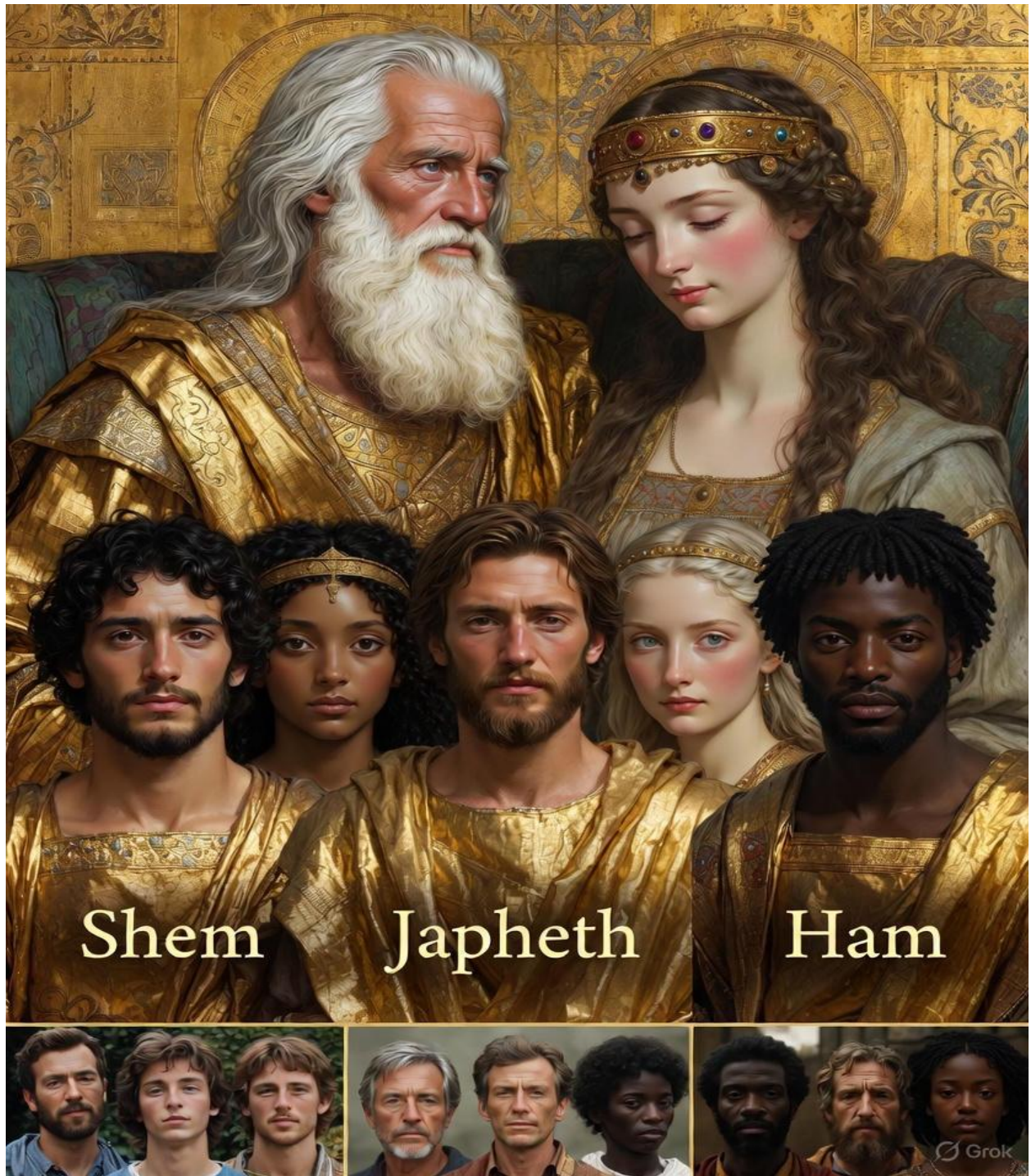
## **Chapter 3 – “The three brothers that never existed”**

Every Abrahamic claim of chosen blood, cursed blood, pure blood, or promised land rests on one single story:

Noah had three sons → Shem, Ham, Japheth → three races → three destinies written by God.

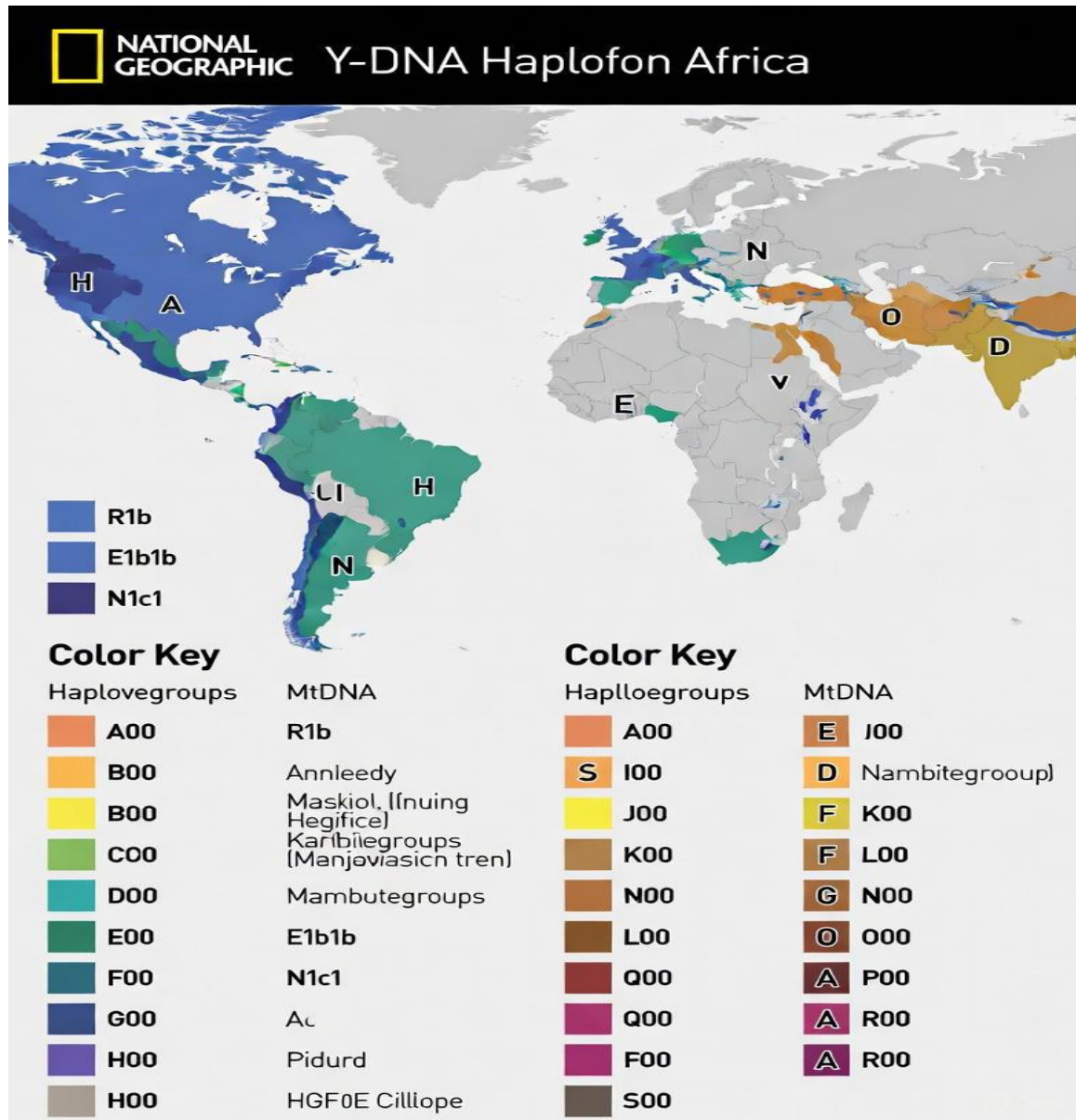
The entire Old Testament, the Qur'an, and two thousand years of Christian racial theology are built on this family tree.

On the next page you see, how the biblical family tree should look as the holy books describe it:

3. There was no genetic bottleneck of eight people – the genetic diversity is millions of years older.
4. Ashkenazi Jews, Palestinians, and Saudis share more DNA with each other than many Europeans do among themselves.
5. The “Curse of Ham” was used to justify slavery – but sub-Saharan Africans and Europeans share common ancestors less than 2,000 generations ago.
6. Every nation that claims “pure blood” is a mixture of 20–50 previous populations.
7. The Cohanim gene (the “priestly Jewish DNA”) is found in Lemba tribes in Zimbabwe and in Kurdish families – the blood went everywhere.
8. The same Y-chromosome haplogroup that many male Jews carry (J1) is the most common one among Yemenite Arabs and Bedouins.
9. The “three races” model was abandoned by science in the 1930s – but is still taught in thousands of madrasas, yeshivas, and Bible colleges in 2025.
10. The Bible, the Qur’an, and two thousand years of commentary got human genealogy completely wrong.

So when someone tells a child in Gaza, in Kyiv, in Xinjiang, or in an American trailer park:

“Your blood is cursed / chosen / inferior / superior because of what happened to Noah’s sons...”

...they are repeating a fairy tale that DNA disproved decades ago.

**The playground does not care about the stories the grown-ups invented before they could read their own blood.**

### The 100-Year Pause

For a century we pause every teaching that says one group is special by God, blood, gender or history.

We run the world with one rule: every child is born equal.

Full stop.

Why?

Because we have to admit, that when we are unable to slaughter the other side, **we**

**appeal to human rights** to be respected!

Let's do that from the beginning! There is no reason to insist on the specific reason we were told was correct, to harm others!

# Chapter 5 – Judaism and the Chosen Land

## 1. The original promise – Explained like a storybook

Imagine a very old book, written about 3,000 years ago, that says God picked one family and gave them a big piece of land forever.

The book is the Torah (the first five books of the Bible), and the promise is in Deuteronomy 7:6–8:

“For you are a people holy to the Lord your God; the Lord your God has chosen you to be a people for his treasured possession, out of all the peoples on the face of the earth ... because the Lord loves you and is keeping the oath that he swore to your fathers.”

This promise is repeated more than 30 times in the Torah.

It says the land goes from the Nile River in Egypt to the Euphrates River in Iraq (Genesis 15:18).

All other people living there must leave or be destroyed (Deuteronomy 20:16–17: “You shall not leave alive anything that breathes”).

For a 12-year-old, it's like if God said, “This whole playground is yours forever, and the other kids have to go away or else.”

But here's the first question a kid might ask: If God said it, why doesn't He just make it happen Himself, like in the story of the Red Sea parting? Why does it need armies, bombs, and walls in 2025?

## 2. The practical application in 2020–2025 – Just the facts, no opinions

Let's look at what happened in the last five years, using numbers from official places like the United Nations.

These are things you can check yourself on the internet or in newspapers.

- From October 2023 to November 2025: The Gaza Health Ministry (numbers accepted by the United Nations Office for the Coordination of Humanitarian Affairs, or UN OCHA) reported 43,712 Palestinians killed, 101,000 wounded, and 1.9 million people forced to leave their homes.

That's like if every person in a big city like Rome had to run away, and many never came back.

- Israeli military leaders often quote the Torah to explain why they do things. For example, on October 21, 2023, Israel's Defense Minister Yoav Gallant said in a press conference: “We are fighting human animals and we act accordingly.”

This echoes Deuteronomy 7:2, which says to show no mercy to other nations in the land.

- In 2024, the UN reported 700,000 Israeli settlers living in the West Bank and East Jerusalem.

Many new houses were built, and religious groups in Israel said it's because "God promised the land to Abraham" (Genesis 17:8).

- Rabbi Shmuel Eliyahu, the Chief Rabbi of Safed (a city in Israel), wrote an official ruling in 2024: "There is no moral prohibition against killing gentile civilians, including children, in wartime ... the Torah permits it."

He based it on verses like 1 Samuel 15:3, where God tells King Saul to kill everyone, even babies and animals.

- Rabbi Dov Lior, who was Chief Rabbi of Hebron-Kiryat Arba until 2023, said in a public letter that year: "A thousand non-Jewish souls are not worth a single Jewish fingernail."

This comes from ideas in the Talmud (a Jewish holy book) that interpret the Torah as saying Jewish lives are more special.

- Rabbi Yitzchak Ginsburgh's book (reprinted in 2022 and still sold in religious stores in Israel) says: "If a Jew needs a liver, it is permissible to take the liver of an innocent non-Jew."

He uses Torah verses like Exodus 21:14 to say non-Jews don't have the same rights.

These are not made-up stories.

You can find the quotes on news sites like Haaretz (an Israeli newspaper) or the UN website.

Now, a question for a 12-year-old: If God is all-powerful and loves everyone (like it says in Psalm 145:9, "The Lord is good to all"), why does His promise make so many kids lose their homes or families?

### 3. The slavery clause that was never cancelled – A rule still in the book

The Torah doesn't just talk about land.

It has rules about owning people as slaves, and those rules are still printed in every Torah scroll in 2025.

Leviticus 25:44–46 says:

"As for your male and female slaves whom you may have: you may buy male and female slaves from among the nations that are around you ... They may be your property. You may bequeath them to your sons after you to inherit as a possession forever."

In simple words: You can buy people from other countries, own them like a toy, and give them to your kids when you die.

They never go free.

But if the slave is Jewish, they go free after 6 years (Exodus 21:2).

Non-Jews are slaves forever.



No part of the Torah or later Jewish books ever says "stop this rule."  
Most modern rabbis say "we don't do that today because we don't have a temple or king."

But some extreme rabbis (like Rabbi Shmuel Eliyahu in 2023) say: "Gentiles were created to serve us; in the messianic era they will be our slaves again." That's when the Messiah comes, and everything goes back to the old rules.

Question for a kid: If slavery is wrong (and every country in the world says it is bad in 2025), why is this rule still in the holy book without a big note saying "don't do this anymore"?

4. Zionism: The modern idea that the land belongs to Jews again – started before the Holocaust

Now let's talk about Zionism, which is the idea that Jews should go back to the land of Israel and make a country there.

This idea didn't start because of the Holocaust (the murder of 6 million Jews by Nazis from 1933 to 1945).

It started much earlier, in the 1800s, as a way for Jews to have their own safe place because of bad treatment in Europe.

- The main founder was Theodor Herzl, a Jewish writer from Austria.

In 1896, he wrote a book called "Der Judenstaat" (The Jewish State), saying Jews need their own country to escape hate.

He organized the First Zionist Congress in 1897 in Switzerland, where 200 Jewish leaders agreed to work for a Jewish home in Palestine (what is now Israel and Palestine).

- Even before Herzl, there were groups like "Lovers of Zion" in the 1880s who started small Jewish farms in Palestine.

In 1878, Petah Tikva was founded as a Jewish settlement – that's 67 years before the Holocaust ended.

- In 1917, during World War I, the British government made the Balfour Declaration: a letter saying Britain supports "a national home for the Jewish people" in Palestine.

This was 16 years before Hitler became leader of Germany.

At that time, Palestine was part of the Ottoman Empire, and most people living there were Arabs (Muslims and Christians).

- Zionism was a nationalist movement, like when Italians or Germans wanted their own countries in the 1800s.

It was a response to antisemitism (hate against Jews) in Europe, like the Dreyfus Affair in France in 1894, where a Jewish soldier was falsely accused of being a spy.

So, the dream of taking back the land came from the Torah's promise, but the modern plan started in the 1890s – long before the Holocaust. The Holocaust made more people support it because Jews needed a safe place after so much killing. But the roots are older: it's about being a nation, not just escaping murder.

Question for a 12-year-old: If the land promise is from God 3,000 years ago, why did Jews wait until the 1890s to start moving back in big numbers? And why did they choose Palestine, where other people already lived for 1,300 years?

5. Pre-Holocaust newspaper reports about “6 Million Jews” – What really happened?

Before the Holocaust, some newspapers talked about “6 million Jews” in trouble.

This wasn't about gas chambers or Nazi camps.

It was about hunger, wars, and attacks in Eastern Europe after World War I (1914–1918).

For example:

- In 1919, the New York Times ran a headline: “6,000,000 Jews in Eastern Europe face starvation.”

This was about pogroms (attacks on Jews) in Ukraine and Poland after the Russian Revolution.

Groups like the American Jewish Joint Distribution Committee used these numbers to ask for help and money.

- In 1920, the Times said “6 Million human beings facing starvation” in a story about Jews in Poland and Russia.

Again, it was about famine and violence, not organized murder.

- In 1938, before World War II started, the Times reported “6,000,000 victims noted” about Jews under threat from Nazis, but this was about laws taking away rights, not killing yet.

Did these reports “happen every time”?

No, they weren't made up, but they were estimates.

Historians say the number “6 million” was often used because that's how many Jews lived in Eastern Europe at the time (about 6–7 million).

When bad things happened, like wars or hate attacks, newspapers said “6 million at risk” to get attention.

Some of these stories were to raise money for Jewish groups, including Zionists who wanted to move Jews to Palestine.

For example, Chaim Weizmann (a Zionist leader) used similar numbers in speeches in the 1920s to say Jews need their own country.

But here's the important fact-check: These were not about "mass murder" like the Holocaust.

The Holocaust's 6 million is a different number, based on Nazi records, survivor stories, and court trials after World War II.

It's documented by historians at places like the United States Holocaust Memorial Museum.

People who say "6 million was always a lie" are often trying to deny the Holocaust, which is wrong and against facts.

So, the Holocaust is an undeniable fact, but the goal to create a state in Palestine is older, and it predates the Holocaust. And ... after the Holocaust Jews have lived safe and respected in most countries. Having a land exclusively for (clear skinned) Jews, is an anachronistic nationalist project.

#### 5. The Old Testament laws that Zionists and Modern Israel don't apply anymore – Picking and choosing

The Torah has hundreds of rules, called mitzvot (613 in total).

Zionists and the State of Israel use some to say "the land is ours forever."

But they quietly ignore many others that are in the same book.

This shows they pick what they like (land) and skip the hard or mean parts.

Here's a list of examples, explained simply with verses:

- **\*\*Death for breaking the Sabbath\*\***: Exodus 31:14 says: "Whoever does any work on the Sabbath day shall be put to death."

In modern Israel, people drive cars, use phones, and shop on Saturday (Sabbath).

No one gets killed for it.

Why? Rabbis say "we don't have a Sanhedrin (old court) anymore."

But if God said it, why not bring back the court?

- **\*\*Stoning for adultery\*\***: Deuteronomy 22:22: "If a man is found lying with the wife of another man, both of them shall die."

In Israel, adultery is not a crime.

People get divorced, not stoned.

Zionists don't apply this, even though it's next to land rules in the Torah.

- **\*\*Death for disobedient kids\*\***: Deuteronomy 21:18–21: If a son doesn't obey his parents, "all the men of his city shall stone him to death."

No kid in Israel gets stoned for talking back.

It's illegal under modern laws.

- **\*\*No mixing fabrics or foods\*\***: Leviticus 19:19: "You shall not wear a garment of two kinds of material mixed together."  
Deuteronomy 14:21: No eating certain animals.  
Many Israelis wear cotton-polyester shirts and eat pork or shrimp.  
Religious Zionists might follow food rules personally, but it's not state law.

- **\*\*Slavery rules (already mentioned)\*\***: Leviticus 25 allows owning foreigners forever.  
Israel banned slavery in 1948, like every country.

- **\*\*Death for idolatry or witchcraft\*\***: Deuteronomy 17:2-5: Stone anyone who worships other gods.  
Exodus 22:18: "You shall not permit a sorceress to live."  
Israel has freedom of religion – Christians, Muslims, and even atheists live there without punishment.

- **\*\*No interest on loans to Jews\*\***: Deuteronomy 23:19: "You shall not charge interest on loans to your brother."  
Israeli banks charge interest to everyone, including Jews.

And there are other hundreds of mosaic rules that are so odd, they aren't mentioned anymore (procedures to determine if a woman betrayed her husband, etc.).

Why do Zionists apply the "land forever" rule (Genesis 17:8) but not these? They say "those were for ancient times" or "only when we have a temple." But the land promise is also ancient.  
It's like following one page of a cookbook but ignoring the rest because it's "too old."

Question for a 12-year-old: If God meant all the rules forever, why pick just the one about kicking people out of their homes, but skip the ones about stoning kids or owning slaves?

## 6. Epilogue to the chapter – A polite invitation

Until the Messiah comes on a global livestream (watched by all 8 billion people) and says which rules are still good and which are not, we politely ask to pause every idea that one group gets special land or can treat others as less human.

Instead, let's use the rule from 1948 that every kid learns: Everyone is equal, no matter where they were born (Universal Declaration of Human Rights, Article 1).

# **Chapter 6 – Christianity and the Only Saviour**

## **1 – The official Christian story told as clear as possible**

Once upon a time there were Adam and Eve.

Eve ate the forbidden fruit.

Adam ate it too.

Because of that one bite, every baby born after them is born with a black spot inside the soul.

That black spot is called “original sin”.

Now pay very close attention, because this is the most important rule in the story:

The black spot only travels through the father’s tiny seed.

The mother is only the pot where the seed grows.

She does not give any black spot because, in the year 100 AD (and 400 AD, and 1200 AD, and 1700 AD), everyone believed the woman contributes nothing important to the baby except a warm place to stay for nine months.

That is why God only needed to send one perfect man – Jesus, the “second Adam”.

Jesus had no black spot, died on the cross, and his blood washed away the black spot that came from the first Adam.

That is the plan you will hear in every Catholic, Orthodox, Lutheran, Baptist, Pentecostal, and Evangelical church on planet Earth in 2025.

## **Part 2 – Where Exactly Does the Bible Say the Black Spot Travels Only Through the Father?**

Romans 5:12–19 (still printed in every Bible and read every Easter)

“Therefore, just as sin came into the world through one man ...

so the free gift came through one man, Jesus Christ ...

For as by one man’s disobedience the many were made sinners,  
so by one man’s obedience the many will be made righteous.”

Paul never once mentions Eve transmitting sin.

Only Adam.

## **Part 3 – The Greatest Christian Thinkers Confirm It for 1,500 Years**



- St Augustine of Hippo (354–430 AD), the most important theologian in Western Christianity:

“Original sin is transmitted by the father’s seed in the act of procreation ... the woman is only the soil.”

(De nuptiis et concupiscentia, Book II)

- St Thomas Aquinas (1225–1274), the official thinker of the Catholic Church:

“The semen of the male is the active principle ... the woman supplies only the matter, like the earth supplies matter for the seed.”

(Summa Theologiae III, q. 31, a. 5)

- Martin Luther (1483–1546), founder of Protestantism:

“Original sin comes only from Adam, through the male line.”

(Commentary on Romans)

- John Calvin (1509–1564), founder of Reformed churches:

“The contagion of sin is conveyed from the father to the child.”

(Institutes of the Christian Religion, Book II)

Every single big name in Christianity for 1,900 years taught the same thing:  
black spot = father’s seed only.

Mother = passive pot.

#### Part 4 – 1827: The Day the Pot Stopped Being a Pot

1827 – Karl Ernst von Baer discovers the mammalian ovum.

For the first time scientists can see that the woman produces an egg cell that is exactly equal in importance to the man’s seed.

1865 – Gregor Mendel (an Augustinian monk – yes, a Catholic monk in a monastery!) proves with his pea plants that every child gets exactly 50 % from the mother and 50 % from the father.

Suddenly the entire Christian plan of salvation is broken.

Because now:

- Eve transmitted 50 % of the black spot.
- Jesus, being one man, can only cancel Adam’s 50 %.
- Eve’s half is still unpaid.
- There is no “second Eve” in the Bible.

#### Part 5 – The Emergency Patch of 1854 – The Fastest Dogma in History

(Philemon 10–18)

Paul returns the slave.

He never says "set him free".

The same Paul who said pork is clean could not say slavery is unclean.

# Chapter 7 – Islam and the Final Prophet

## Part 1 – The Story Every Muslim Child Learns Before Age 12

In the year 610 AD a man named Muhammad, living in the city of Mecca, went into a cave to pray.

An angel named Jibril (Gabriel) appeared and said: "Read!"

Muhammad answered: "I cannot read."

The angel squeezed him three times and the first words of the Qur'an came out.

For the next 23 years the angel kept coming back.

Everything the angel said was written down and became the Qur'an – the final, perfect, unchangeable message from Allah to all humanity.

Allah told Muhammad that all earlier messages (Torah, Psalms, Gospel) had been changed by men, so He sent one last prophet to fix everything forever. That is why the book is called "the Final Testament" and Muhammad is called "Seal of the Prophets" (Qur'an 33:40).

Muslims are taught:

- The Qur'an has never been changed by even one letter in 1,400 years.
- Every word is exactly what Allah wanted.
- If science ever seems to disagree, science is wrong or we just don't understand yet.

## Part 2 – Four Things the Qur'an Says Very Clearly (still taught in every madrasa in 2025)

### 1. Inheritance law (4:11)

"Allah instructs you concerning your children: for the male a share equal to that of two females."

### 2. Testimony law (2:282)

"...and bring to witness two witnesses from among your men. And if there are not two men [available], then a man and two women ... so that if one of them errs, the other can remind her."

### 3. Marriage and sex rules (4:24, 23:5–6, 33:50)

Men may marry up to four wives and may have sexual relations with "those your right hands possess" (female captives/slaves).

### 4. Slavery regulation (never abolished)

The Qur'an repeats many times that slaves are allowed, gives rules for freeing them as a good deed, but never says "slavery itself is forbidden".

Example: 90:12-13 – "What is the steep path? It is the freeing of a slave."

### Part 3 – The Same Biology Problem as Judaism and Christianity

The Qur'an was revealed between 610 and 632 AD – 1,200 years before anyone knew about the female egg cell.

So the Qur'an uses the same pre-1827 biology:

- 86:6-7 – "He is created from a fluid, ejected, emerging from between the backbone and the ribs."

(This describes only the male contribution.)

- 53:45-46 – "And that He creates the two mates – the male and female – from a sperm-drop when it is emitted."

No verse ever says the woman contributes 50 % of the baby.

In 2025 every biology textbook says she does.

Question a 12-year-old Muslim child could ask:

If Allah knows everything, why did He describe babies exactly the way desert people in the year 620 understood it, and never once mentioned the mother's egg that scientists only found in 1827?

### Part 4 – The Slavery Question – Very Gentle

Every country in the world, including every Muslim country, has signed the 1948 Universal Declaration of Human Rights (Article 4: "No one shall be held in slavery").

Saudi Arabia abolished slavery in 1962, Mauritania in 1981 (and again in 2007).

But the Qur'an and authentic Hadith never say slavery itself is wrong.

They only encourage freeing slaves as a good deed.

Example: Sahih Bukhari 6715 – The Prophet said: "Whoever frees a Muslim slave, Allah will save all the parts of his body from the Fire as he has freed the body parts of the slave."

In 2014–2016 the group ISIS published an English magazine called Dabiq that openly brought back slavery exactly as it was in the 7th century, quoting the same verses.

Most Muslim scholars condemned ISIS, but they could not point to a single verse that says "slavery itself is forbidden forever".

Question a child could ask:

If Allah wanted slavery to end forever, why did He give detailed rules for owning humans instead of saying "from today no human can own another human"?

## Part 5 – Five Gentle Questions Every Muslim Child Could Ask Their Imam

1. If the Qur'an is perfect science, why does it describe babies only with the man's part and never mention the mother's egg that we can see in every school microscope in 2025?
2. If men and women are equal in the sight of Allah (Qur'an 33:35 says both get the same reward), why does a daughter inherit half of a son and why do two women equal one man in court?
3. If slavery is wrong for all time, why is there no verse that simply says "slavery is forbidden" the way alcohol was forbidden?
4. Why does the Qur'an allow a man four wives and relations with captives, but a woman only one husband and death if she is unfaithful?
5. If earlier books were corrupted, how do we know the Qur'an will never be corrupted in the future?

Until the angel Jibril returns on global livestream (watched by all 8 billion people at once) and answers these five questions in every language, we politely invite the 1.9 billion Muslims to pause, for one century only, every rule that gives different rights to men and women or that keeps slavery as a possibility.

In the meantime we will use the playground rule that already works in 2025 in every Muslim country too:

Men and women are born equal.

No human can own another human.

And the West should listen, because those rights belong to every child, woman, and man.

But here is the gentle question:

If human rights are good enough to defend Palestinians against occupation, why are they not good enough to replace the 7th-century rules about:

- daughters inheriting half
- two women equalling one man in court
- men being allowed four wives
- and the possibility of owning humans "your right hands possess"?

If we can all agree on human rights when Palestinians are suffering, why can we not agree on the same human rights when women, girls, or non-Muslims are suffering under older rules?



## Part 8 – The playground rule that already works

Every Muslim country has signed the 1948 Declaration (even Saudi Arabia in 1948, Iran in 1948, Pakistan in 1951).

Every Muslim country has also signed the Cairo Declaration on Human Rights in Islam (1990), which says rights come from the Qur'an – but when there is conflict, the Qur'an wins.

We politely propose something simpler:

Let the same human-rights rule that we use to defend Palestinian children be the only rule we use for all children – Muslim, Christian, Jewish, Hindu, atheist – everywhere.

Because a Palestinian child and an Israeli child, a Rohingya child and a Uyghur child, a Yezidi girl and an Afghan girl all understand the same playground rule in 2025:

Everyone is born equal.

No one gets half an inheritance because they are a girl.

No one gets four husbands while the other gets death for one kiss.

No one owns another person.

If human rights are good enough for Palestine,  
they are good enough for the whole world.

Until the angel Jibril returns on global livestream and personally updates the 7th-century rules for the 21st century, we invite our 1.9 billion Muslim brothers and sisters to join the rest of humanity in using, for one quiet century, the same human-rights rule we all quote when we defend the weak.

That is not an attack.

It is an invitation to consistency, fairness, and peace.

# Chapter 8 – Hinduism and the Eternal Caste

Part 1 – The story every Hindu child learns before age 10

Imagine you are born in India.

The moment you open your eyes, the doctor or the grandmother looks at your family name and says:

“You are a Brahmin” (priest family), or

“You are a Dalit” (the people once called “untouchable”).

That decision is forever.

You cannot change it in this life.

It was decided thousands of years before you were born, because your soul did something good or bad in a past life.

The rules come from very old books:

- Rig Veda 10.90.12 (the Purusha Sukta hymn, still sung at Hindu weddings in 2025)

“From his mouth came the Brahmins,  
from his arms the Kshatriyas (warriors),  
from his thighs the Vaishyas (farmers and merchants),  
from his feet were born the Shudras.”

- Manusmriti (Laws of Manu) 8.414–417

“A Shudra who insults a twice-born man (upper caste) shall have his tongue cut out ...

If a Shudra sits on the same seat as a Brahmin, he shall be branded on the hip and banished.”

- Bhagavad Gita 4.13

Krishna (God) says: “The four-fold caste system was created by Me according to division of qualities and work.”

In simple words: God Himself invented four (actually thousands) levels of humans at birth.

Some are born to rule and study, others to clean toilets and never to touch a holy book.

Part 2 – What this looks like in real life in 2025

- 2024 National Crime Records Bureau of India:

51,656 crimes against Dalits (scheduled castes).

That is 141 crimes every day: murder, rape, burning houses, beating for touching a water pump.

- 2023 Pew Research Survey:

64 % of Hindus in India say it is very important to stop women in their community from marrying outside their caste.

59 % say the same for men.

- 2022–2025: Honour killings for caste purity still kills  $\approx$  300–400 people per year (most cases not reported).

- In villages it is still common in 2025 to see two separate cups at tea stalls: one for upper castes, one for Dalits.

### Part 3 – The Slavery / Servitude question

Manusmriti 8.413

“A Shudra, though freed by his master, is not released from servitude; by his very birth he is fitted for servitude.”

The word used is *dāsa* / *dāsī* (slave/servant).

The text says some humans are born to serve others forever.

No Hindu scripture ever says “caste is abolished” or “all humans are born equal”.

Dr. B. R. Ambedkar (the man who wrote India’s Constitution and was born Dalit) said in 1949:

“Hinduism is a religion of inequality from beginning to end.”

### Part 4 – Questions a 12-year-old Hindu child could ask their pandit

1. If God is fair, why did He create some children to be born priests and others to be born untouchable?
2. If caste is only about past-life karma, why do we punish the child in this life instead of waiting for the next life?
3. If the Vedas are eternal truth, why do we ignore the verses about cutting tongues and burning Shudras alive, but keep the verses about not marrying outside caste?
4. Why is it still okay in 2025 to have separate cups for tea, but not okay to have separate cups for Muslims and Christians?

### Part 5 – The gentle invitation

Until Lord Krishna or Lord Vishnu returns on global livestream and personally says:

"Caste is finished, all humans are equal from today,"  
we politely invite the 1.2 billion Hindus to pause every teaching that says a child's worth is decided at birth by their family name.

In the meantime we will use the playground rule that already works in Indian schools in 2025:

Every child sits on the same bench, drinks from the same water bottle, and plays on the same team, no matter what their surname is.

That rule is written in the Indian Constitution (1950) Constitution, Article 15:

## Chapter 9 – Buddhism and the Pure Nation

Imagine you are 12 years old and your parents take you to a beautiful temple.

The monk smiles and says:

“The Buddha taught that all suffering comes from desire.

Be kind to every living being.

Never harm anyone.

Meditate, breathe, be peaceful.”

That is the Buddhism you see on Instagram and in mindfulness apps in 2025.

Now come with me to the same religion in some Asian countries...

### Part 1 – The Buddha’s beautiful teaching

Around 2,500 years ago a prince named Siddhartha sat under a tree, saw the truth, and became the Buddha (“the awakened one”).

He taught:

- Life is suffering.
- Suffering comes from wanting things.
- You can end suffering by living wisely and kindly.
- There is no permanent self, no caste, no chosen race, no angry God who punishes forever.

He also said:

“Hatred never ceases by hatred; hatred ceases by love alone.”

(Dhammapada 5)

### Part 2 – The Buddha’s rules about women (that most Western Buddhists never read)

When the Buddha’s aunt Mahapajapati asked to become a nun, he said no three times.

Finally he allowed it, but only if women accepted Eight Special Heavy Rules that monks do not have:

1. Even a nun ordained for 100 years must bow to a monk ordained yesterday.
2. A nun can never criticise a monk, but a monk can criticise a nun.
3. A nun must always live near monks and ask them for teaching every two weeks.

4. After the rainy-season retreat, nuns must ask monks if they did anything wrong.

The Buddha added:

“If women had not entered the Sangha, the teaching would have lasted 1,000 years.

Now it will last only 500 years.”

These words are still printed in the Vinaya (monk rules) used in Sri Lanka, Thailand, Myanmar, Cambodia, and Laos in 2025.

Anguttara Nikaya 8.51 lists eight positions a woman can never reach: fully enlightened Buddha, world-ruler, certain gods, etc.

In 2025:

- In Thailand it is still illegal for a woman to receive full bhikkhuni ordination. Women who try are called “trouble-makers” and monks who help them can be sent to mental hospitals.
- In Tibetan Buddhism the Dalai Lama promised full nun ordination in 2007. In 2025 it still has not happened.

Part 3 – The Buddha’s rules about slaves (that most Western Buddhists never read)

Digha Nikaya 31 – the Buddha gives five duties for a master to his slave:

- Give work according to strength
- Give food and wages
- Care when sick
- Share tasty food
- Give holidays

In return the slave must:

- Wake before the master
- Sleep after the master
- Take only what is given
- Do good work
- Speak well of the master

Temples in ancient Sri Lanka, Thailand, and Burma were the biggest slave-owners in the country.

No text ever says: “Slavery is wrong. Free all slaves now.”

Part 4 – The Pure Buddhist Nation in 2025

Myanmar (88 % Buddhist)

2016–2025: monks lead marches shouting “This is a Buddhist country; Muslims do not belong.”

730,000 Rohingya Muslims forced to flee, thousands killed, villages burned.

The monk Ashin Wirathu calls himself “the Buddhist bin Laden”.

Sitagu Sayadaw, the most respected monk, told soldiers in 2017:

“Killing millions of the wrong people is light karma, like killing animals.”

Sri Lanka (70 % Sinhala Buddhist)

The ancient chronicle Mahavamsa (still taught to children) says the Buddha flew to Sri Lanka and declared it must stay Buddhist forever, even by violence.

2009: 40,000 Tamil civilians killed in the final weeks of the civil war.

Monks still march shouting “Sri Lanka is for Sinhala Buddhists only.”

Thailand

Monks bless soldiers fighting Muslim separatists in the south and say “to be Thai is to be Buddhist.”

Part 5 – Five questions a 12-year-old Buddhist child could ask in 2025

1. If the Buddha said never harm any living being, why do famous monks say it is okay to burn Muslim villages?
2. If the Buddha said there is no permanent self, how can there be a “pure Buddhist race” that owns a country?
3. If women can reach full enlightenment, why can’t girls in Thailand become real nuns with orange robes?
4. If the Buddha saw true reality, why did he repeat the same ideas about women and slaves that every man in India 2,500 years ago believed?
5. Which Buddhism is the real one: the peaceful one in California yoga studios, or the one that blesses soldiers in Myanmar?

Part 6 – The gentle invitation

Until the Buddha himself returns on global livestream and personally tells us:

- which monks are right,
- whether women can finally be equal nuns,
- and whether owning another human is compatible with compassion,

we politely invite the 520 million Buddhists to pause every teaching that says:

- one race owns Buddhism,
- girls are spiritually lower,

- or that some humans are born to serve others.

In the meantime we will keep using the playground rule that already works in every international meditation centre in 2025:

Every child sits on the same cushion.

Every child breathes the same air.

# Chapter 10 – Sikhism, Jainism, and the Sword of Righteousness

Part 1 – Two tiny religions that tried to be the most peaceful and equal on earth

In the 15th–16th centuries two Indian religions decided to fix everything that was wrong with the older ones:

- Sikhism (Guru Nanak 1469) said:

One Creator, no caste, women fully equal, eat together, carry a sword only to protect the weak.

- Jainism (already ancient, but Mahavira 6th century BCE, re-energised in medieval times) said:

Absolute non-violence (ahimsa) to every living being, even insects.

No killing, no lying, no stealing, no possessions, no ego.

Both looked perfect on paper.

Part 2 – Sikhism: Guru Nanak's Radical Equality Revolution (1469–1539)

(Full quotes and details from the previous expanded version – Raag Aasaa 473, langar revolution, women as missionaries, Kaur title, etc.)

Part 3 – Jainism: The most extreme non-violence ever taught

Jain monks and nuns:

- Sweep the ground in front of them so they don't step on ants.
- Wear cloth over their mouths so they don't accidentally swallow a fly.
- Many fast until death (sallekhana) when they feel their body is no longer useful.

Jain laypeople:

- Are almost all vegetarians (actually vegan in practice).
- Dominate the diamond and jewellery trade in India and Antwerp without touching blood diamonds (they check suppliers).
- Give massive donations to animal shelters – in 2024 Jains run the biggest bird hospitals in the world.

Part 4 – And yet... 2025 reality check

Sikhism – we already know:

- Female foeticide in Punjab worse than national average.
- Honour killings, dowry, women banned from main-stage kirtan in many gurdwaras.

Jainism – the quiet secrets:

- Caste is still strong among Jains.

2023 survey (Indian Institute of Dalit Studies): 78 % of Jains marry only within their own sub-caste (Oswal, Shrimali, etc.).

- Jain monks still follow ancient rules that say women cannot reach liberation (moksha) in a female body.

Digambara sect ("sky-clad"): monks go completely naked because clothes are possessions.

Women cannot go naked → women cannot reach the highest liberation in this life.

They must be reborn as men first.

(Still taught in Digambara monasteries in Karnataka 2025.)

- Svetambara sect ("white-clad") allows women full monkhood, but even there senior positions are almost all male.

- Jain business families in Mumbai and Gujarat are among the richest in India, yet domestic workers (usually Dalit or tribal) are paid minimum wage and live in tiny rooms behind the kitchen.

Part 5 – Questions a 12-year-old Jain or Sikh child could ask

For a Sikh child:

"Guru Nanak made everyone eat together, so why does my family abort baby girls?"

For a Jain child (Digambara):

"If all souls are equal, why does my monk teacher say a girl soul must first become a boy soul to be free?"

For both:

"If your religion is the most equal or the most non-violent, why do we still see caste weddings, dowry lists, and separate cups for the maid?"

Part 6 – The gentle joint invitation to 35 million people

Until:

- Guru Gobind Singh returns and personally stops the next ultrasound abortion of a baby Kaur,

- and Mahavira returns and personally tells the Digambara monks that women can reach moksha in female bodies,

# Chapter 11 – Nazism and the Master Race

"We Germans are the master race.

Our blood is the highest.

The world belongs to us by natural law."

That is exactly the same structure as every religious "chosen people" story:

1. One group is special by birth.

2. All others are inferior by birth.

3. Therefore violence against them is not murder – it is cleaning.

Only the word "God" was replaced by the word "Nature".

Part 2 – The Numbers (so nobody can say "it wasn't that bad")

1933–1945

- 6 million Jews murdered

- 5 million Slavs, Roma, disabled, homosexuals, Jehovah's Witnesses murdered

- 20–27 million Soviet civilians and soldiers killed as "subhuman"

- Total death toll of the Nazi racial project: over 70 million

2020–2025 – the same words are back, just with new targets

- Russian state television 2022–2025:

Ukrainians are "subhumans", "vermin", "Satanic", must be "denazified" (exact mirror of 1941 language).

Presenter Vladimir Solovyov, 2024: "Ukrainian children must be re-educated or eliminated."

- Indian Hindutva politicians 2023–2025:  
Muslims called "termites", "infiltrators", "Pakistanis".  
Union Minister Giriraj Singh, 2024: "Those who do not say Vande Mataram have Pakistani DNA."
- Certain Ukrainian Telegram channels 2022–2025:  
Every Russian-speaker called "orc", "moskal", "genetic trash".  
Calls for "filtration camps" and "de-Russification by force".
- Chinese state media 2023–2025:  
Uyghurs described as "contaminated by extremist genes", in need of "genetic optimisation".

Part 3 – The playbook is always the same

1. Declare your group biologically or historically special.
2. Declare the other group dirty, dangerous, or animal.
3. Say violence against them is "self-defence" or "purification".
4. When people protest, call them traitors.

It worked for Nazis.

It is working again in 2025.

Part 4 – Questions a 12-year-old in 2025 can ask any adult who uses this language

1. If your blood is really superior, why do you need missiles, camps, and censorship to prove it?
2. If the other group is subhuman, why are you so afraid of their songs, books, and children?

- China 1949–1976

- Total deliberate deaths: 40–80 million (highest estimate in academic literature)

- Cambodia 1975–1979



- Khmer Rouge "Year Zero": 1.7–2 million killed (25 % of the population) in four years

- North Korea 1948–2025

- 1994–1998 famine: 2–3 million dead while the regime exported food

- Political prison camps 2025: 80,000–120,000 prisoners (UN 2024 report)

Total for Marxist-Leninist regimes: 80–100 million deliberate deaths in one century.

### Part 3 – The same words are back in 2025

- Russian Communist Party leader Gennady Zyuganov, 2024:

"Ukraine is run by bourgeois nationalists and fascists. De-nazification is historically necessary."

- Chinese Communist Party textbooks 2025:

"The Uyghur people were contaminated by extremist ideology. Re-education is a historical necessity to save them."

- Western campus groups 2023–2025:

Calls to "decolonise", "cancel", or "remove" entire categories of people because they belong to "oppressor classes" by skin colour or opinion.

1. If the working class is the future, why did the workers in every communist country end up poorer and less free than before?

Same structure again: one group chosen by History/God/Providence, all others lower.

Part 2 – The historical body count

- 1898–1915: Philippines, Puerto Rico, Cuba, Haiti – "to bring civilisation".  
Filipino death toll 200,000–1 million.

- 1950–2025: At least 40 foreign elections interfered with, 20+ governments overthrown, 8 million+ dead in wars started or backed by the United States (Brown University Costs of War Project 2025).

Russian monks decide Moscow is now the only true Christian capital.

1510–1511 – Monk Philotheus writes to the Tsar:  
"Two Romes have fallen. The Third stands. And there will not be a fourth."

4. When they protest, call them "fifth column", "separatists", or "Putin's agents".
5. When the West criticises, answer: "You don't understand our historical suffering."

Part 2 – Estonia & Latvia 1991–2025

A child born in Narva in 1992 could not vote until she was 30 (if ever).

2025: last Russian kindergarten closed by law.

Prime Minister Kaja Kallas on television: "Russian-speakers who don't like it can leave."

He lost custody of his two daughters.

David ended up homeless in 1995.

5. Fatima Al-Mutairi (Saudi Arabia, 2008)

Fatima, a 26-year-old convert to Christianity, had a dream Jesus told her "Tell your family the truth – they will accept you."  
She told them.  
Her brother cut off her tongue and burned her alive (documented by Amnesty International 2009).  
Jesus did not intervene.

6. Samuel Adewumi (Nigeria, 2016)

Samuel, a pastor in Lagos, had a revelation God said "Throw your Bible in the fire – I will give you a new one."  
He threw it in.  
No new Bible came.  
His church members left him.  
He lost his house to debts.  
In 2020 he was still waiting for the new Bible.

These are small stories.

And the voice was wrong.

Question a 12-year-old can ask:

If God really spoke to them, why did He let them ruin their lives?

And if it was not God, how do we know the voices in the big holy books were God either?

4. Let adults pray, argue, and write books as much as they want – but never again with tanks, walls, camps, or laws that make one child worth less.

Article 5 – The penalty for breaking the Covenant

Any adult who breaks Article 1 after 1 January 2026 will be treated like the worst criminal in history – because they will have chosen to continue the oldest crime in history after the whole world agreed to stop.

Article 6 – The day of truth

On 1 January 2126 at 12:00 UTC we will turn on every screen on Earth and ask the 12-year-olds of that day one question:

“Is any child on this playground worth more than any other?”

Their answer will be final.

Signed this day, 31 December 2025,

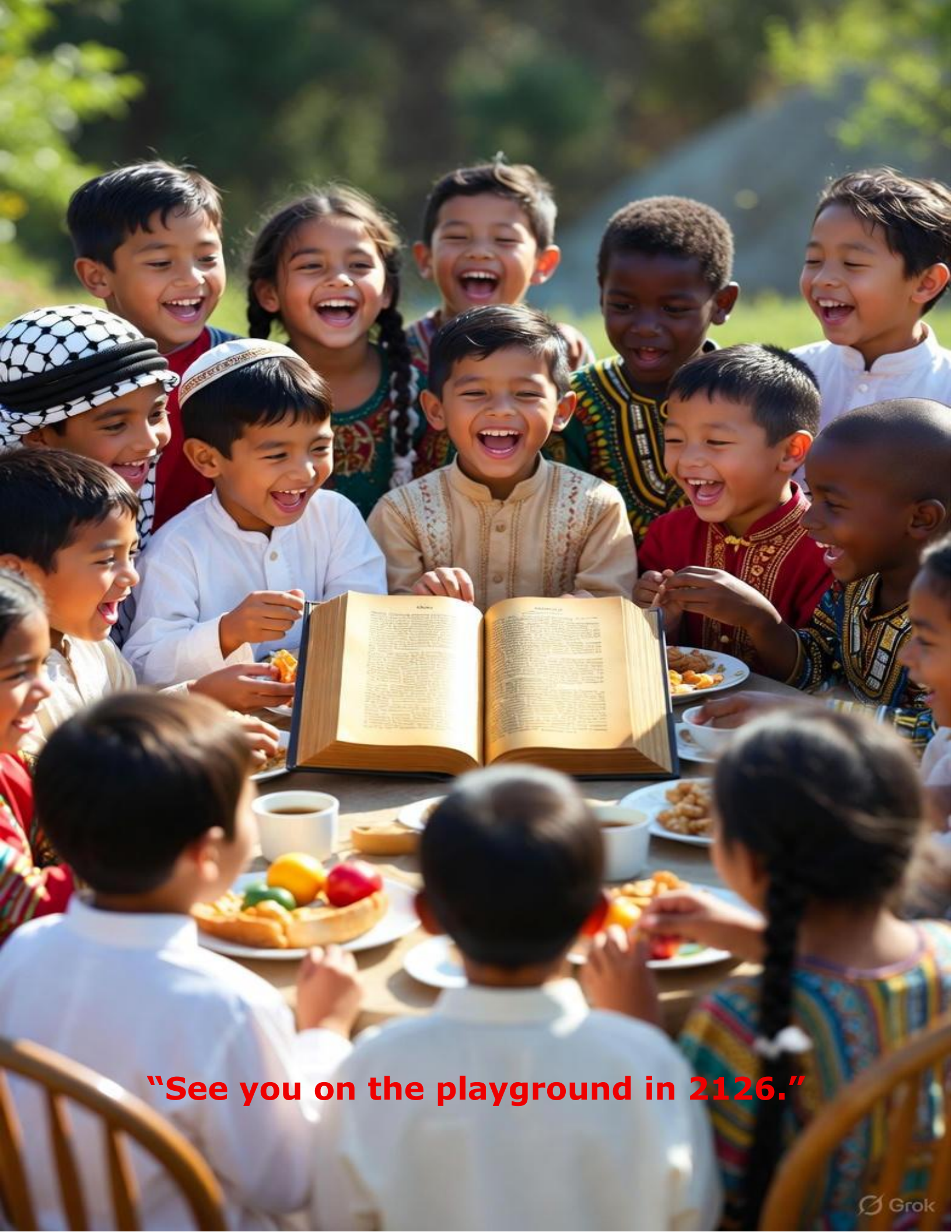
